- Provide proof of ownership (Recorded Grant Deed/Closing Documents).
- Proof of EIN (provided by IRS)
- Please include the effective date for the direct deposits.

### LANDLORD RESPONSIBILITY CHECKLIST

The following are responsibilities of landlords participating in the Section 8 Existing Rental Assistance Program. Please read and complete this form and have your prospective tenant return it with their move in paperwork.

#### DO YOU UNDERSTAND THE LANDLORD IS RESPONSIBLE FOR: (Initial each responsibility below)

1. \_\_\_\_\_ **Determining** the security deposit amount and collecting the security deposit from the family. This amount cannot exceed the amount charged on the open market. GMHA is not responsible for security deposit payments.
2. \_\_\_\_\_ **Collecting** any costs that occur as a result of damages from the resident.
3. \_\_\_\_\_ **Completing** all initial move-in paperwork. A move-in appointment cannot be scheduled until completed paperwork is submitted to GMHA.
4. \_\_\_\_\_ **Making** sure the utilities are turned on in the unit by the inspection date.
5. \_\_\_\_\_ **Calling** to schedule the move-in inspection with GMHA at (937) 352-0273. This can only be scheduled after the family has attended the move-in appointment. Inspections are scheduled in the order they are received.
6. \_\_\_\_\_ **The execution** of all eviction proceedings. **GMHA MUST BE NOTIFIED** of all eviction proceedings in writing.
7. \_\_\_\_\_ **Any rent** that occurs prior to the unit passing inspection. **GMHA's Housing Assistance Payment (HAP) will not be paid by GMHA until the inspection passes and tenant moves in. No retroactive payments will be made.**
8. \_\_\_\_\_ **Monitoring** the rental unit and tenant for possible damages and/or lease violations. You must notify GMHA immediately if the family has moved out of the unit.
9. \_\_\_\_\_ **Assuring** GMHA that no household members are a parent, grandparent, child, grandchild, sister, or brother of said landlord. This is considered fraud, which is punishable by law, except in matters of accommodation for persons with a disability.
10. \_\_\_\_\_ **Checking** your email for inspection results. If a unit does not pass inspection, a self-certification will be emailed to the landlord and it is the landlord's responsibility to return signed self-certification on all annual inspections. GMHA and the client are not responsible for any rent that has been abated or reduced by GMHA as a result of landlord HQS violations.
11. \_\_\_\_\_ **Allowing** 30 days from the date we receive the final paperwork to process your initial payments from GMHA.
12. \_\_\_\_\_ **Reporting** any tenant or household member subject to a lifetime registration requirement under a state sex offender registration program.
13. \_\_\_\_\_ **Reporting** any tenant or household member engaged in or \_\_\_\_\_ threatening, abusive or violent behavior toward GMHA personnel.
14. \_\_\_\_\_ **Evicting** a tenant or household member who has engaged in illegal use (or pattern of illegal use) of a controlled substance, or whose abuse (or pattern of abuse) of alcohol, is determined by GMHA to interfere with the health, safety and/or right to peaceful enjoyment of the premises by other residents.  
*Note: Landlords are prohibited from evicting clients for the sole reason that the tenant has become a victim of domestic violence, dating violence, sexual assault or stalking.*

15. \_\_\_\_ **Providing** your own lease to the tenant and GMHA. Rent amounts and term dates need to be left blank.  
*Note: It is the owner/landlord's responsibility for all HQS violations not listed as family responsibilities (i.e., tenant-paid utilities not in service, failure to provide or maintain family-supplied appliances, damage caused by household member or guest beyond "normal wear and tear"), even if the violation is caused by the family's living habits (e.g., vermin infestation). Note: Landlords are responsible for the cost of pest control.*
16. \_\_\_\_ **Making** sure there are no outstanding city building code violations that are a violation of HQS.
17. \_\_\_\_ **Submitting** paperwork for mandatory direct deposit.
18. \_\_\_\_ **Providing** GMHA with current phone numbers, mailing address and mandatory e-mail address in writing. The landlord also will need to update this information in GMHA's landlord portal.
19. \_\_\_\_ **Signing** up for GMHA's landlord portal at <https://partners.ourpha.com/GreeneMetro>. As a registered landlord you will be able to easily update your contact information, review your profile, review your upcoming recertifications, check the status of inspections, and monitor your HAP payments by resident.

**Note:** If a lease does not automatically go month-to-month after the initial term of lease, and a new lease must be executed between the landlord and the tenant, as well as a new HAP contract must be executed between the landlord and the GMHA. The new lease between landlord and tenant must also be provided to the GMHA.

**GMHA will not approve rent amounts that exceed amounts charged for \*comparable units in the private unassisted/assisted market. A unit rent is not approved until the inspector determines Rent Reasonableness.**

*\*Comparable means units that are similar in location, physical features and amenities to the unit selected by the family.*

### LANDLORD INSPECTION CHECKLIST

1. **BE SURE YOUR SMOKE DETECTORS ARE WORKING OR YOUR UNIT WILL BE TERMINATED WITHIN 24 HOURS ACCORDING TO NEW GMHA POLICY!**  
A working smoke detector with a live battery must be installed on every level of the unit, including the basement. If any members of the family are hearing impaired, a detector for the hearing impaired must be installed.
2. All interior and exterior ceilings, walls, floor and foundations must be free from serious defects and deterioration.
3. The entire unit, both inside and outside, including window frames, must be free of cracking, scaling, peeling, chipping and loose paint. This prevents exposure to possible lead-based paint hazards when a family with children under the age of six will occupy the unit.
4. Where there are three or more consecutive steps, handrails must be securely attached. This applies to both the interior and exterior of the unit.
5. The unit must be clean and free of roaches, rodents or any infestations.
6. The entire unit including garage, interior and exterior must be free from electrical hazards. All three-prong outlets must be wired correctly. A circuit tester will be used at the time of inspection.
7. Every room used for living must have either two working outlets or one working outlet and a permanently installed light fixture.
8. All light switches and outlets must have secured plate covers. The plate covers must be in good condition.
9. All windows and doors must be weather tight and secure when closed.
10. All windows and doors accessible from the outside must have working, sturdy locks.
11. All operable windows must have a mechanism to secure them in place when open. Weighted ropes or clips should be properly installed. Window screens must be provided.
12. All bedrooms must have at least one operable window for fire escape and ventilation.
13. Approach to the unit must be safe with no danger of tripping.

14. Access to the assisted unit must not be through use of other private property.
15. The bathroom must have either an operable window or an exhaust fan for ventilation. The bathroom must have a light and an electrical outlet.
16. The hot water tank's pressure relief valve must have a discharge line extending down two to six inches from the floor.
17. Water heaters in living areas must have permanent dividers or shields with doors to allow inspectors access to water heater.
18. The flu pipe leading from the furnace and hot water tank must be sealed at the chimney. Also, check to ensure that the flu pipes connecting to the furnace and hot water tank are installed correctly.
19. Every room used for living must have adequate heat source. If the source is gas, it must be vented to the outside. If the source is electric, it must be permanently installed and controlled by a separate thermostat.
20. If the downspouts are present, they must be complete and functional.
21. The unit must be free from any accumulation of garbage or debris, both inside and outside.
22. Clothes dryers must be vented to the outdoors, using flexible metal hose.
23. Plumbing supply and drain lines must be free from leaks and dripping faucets.
24. If appliances are provided by the owner, they must be in proper working order. (All burners work, knobs are present, refrigerator has shelves, bins, seals, etc.)

**These are tips to help ensure your inspection will pass. Please note these are the most commonly failed items but not everything the inspection covers is included on this list.**

## General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

**Future developments.** For the latest information about developments related to Form W-9 and its instructions, such as legislation enacted after they were published, go to [www.irs.gov/FormW9](http://www.irs.gov/FormW9).

### Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

*If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.*

By signing the filled-out form, you:

1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
2. Certify that you are not subject to backup withholding, or
3. Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income, and
4. Certify that FATCA code(s) entered on this form (if any) indicating that you are exempt from the FATCA reporting, is correct. See *What is FATCA reporting*, later, for further information.

**Note:** If you are a U.S. person and a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

**Definition of a U.S. person.** For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien;
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;
- An estate (other than a foreign estate); or
- A domestic trust (as defined in Regulations section 301.7701-7).

**Special rules for partnerships.** Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax under section 1446 on any foreign partners' share of effectively connected taxable income from such business. Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the entity;
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the trust; and
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust (other than a grantor trust) and not the beneficiaries of the trust.

**Foreign person.** If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person, do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515, *Withholding of Tax on Nonresident Aliens and Foreign Entities*).

**Nonresident alien who becomes a resident alien.** Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
2. The treaty article addressing the income.
3. The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
4. The type and amount of income that qualifies for the exemption from tax.
5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

**Example.** Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

## Backup Withholding

**What is backup withholding?** Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

**Payments you receive will be subject to backup withholding if:**

1. You do not furnish your TIN to the requester,
2. You do not certify your TIN when required (see the instructions for Part II for details),
3. The IRS tells the requester that you furnished an incorrect TIN,
4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only), or
5. You do not certify to the requester that you are not subject to backup withholding under 4 above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See *Exempt payee code*, later, and the separate Instructions for the Requester of Form W-9 for more information.

Also see *Special rules for partnerships*, earlier.

## What is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all United States account holders that are specified United States persons. Certain payees are exempt from FATCA reporting. See *Exemption from FATCA reporting code*, later, and the Instructions for the Requester of Form W-9 for more information.

## Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you no longer are tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account; for example, if the grantor of a grantor trust dies.

## Penalties

**Failure to furnish TIN.** If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

**Civil penalty for false information with respect to withholding.** If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

**Criminal penalty for falsifying information.** Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

**Misuse of TINs.** If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

## Specific Instructions

### Line 1

You must enter one of the following on this line; **do not** leave this line blank. The name should match the name on your tax return.

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9. If you are providing Form W-9 to an FFI to document a joint account, each holder of the account that is a U.S. person must provide a Form W-9.

a. **Individual.** Generally, enter the name shown on your tax return. If you have changed your last name without informing the Social Security Administration (SSA) of the name change, enter your first name, the last name as shown on your social security card, and your new last name.

**Note: ITIN applicant:** Enter your individual name as it was entered on your Form W-7 application, line 1a. This should also be the same as the name you entered on the Form 1040/1040A/1040EZ you filed with your application.

b. **Sole proprietor or single-member LLC.** Enter your individual name as shown on your 1040/1040A/1040EZ on line 1. You may enter your business, trade, or "doing business as" (DBA) name on line 2.

c. **Partnership, LLC that is not a single-member LLC, C corporation, or S corporation.** Enter the entity's name as shown on the entity's tax return on line 1 and any business, trade, or DBA name on line 2.

d. **Other entities.** Enter your name as shown on required U.S. federal tax documents on line 1. This name should match the name shown on the charter or other legal document creating the entity. You may enter any business, trade, or DBA name on line 2.

e. **Disregarded entity.** For U.S. federal tax purposes, an entity that is disregarded as an entity separate from its owner is treated as a "disregarded entity." See Regulations section 301.7701-2(c)(2)(iii). Enter the owner's name on line 1. The name of the entity entered on line 1 should never be a disregarded entity. The name on line 1 should be the name shown on the income tax return on which the income should be reported. For example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a single owner that is a U.S. person, the U.S. owner's name is required to be provided on line 1. If the direct owner of the entity is also a disregarded entity, enter the first owner that is not disregarded for federal tax purposes. Enter the disregarded entity's name on line 2, "Business name/disregarded entity name." If the owner of the disregarded entity is a foreign person, the owner must complete an appropriate Form W-8 instead of a Form W-9. This is the case even if the foreign person has a U.S. TIN.

### Line 2
